About QNX Amazon Machine Image

QNX in the Cloud Amazon Machine Image (AMI) is a reference image and starting point for developers to leverage the QNX Neutrino RTOS or the QNX OS for Safety as Amazon cloud virtual machine instances. This guide describes how to set up QNX AMI instances on Amazon Elastic Compute Cloud (Amazon EC2) and quickly develop a program so you can run it on an AMI instance.

This guide assumes the following:

- You have an Amazon Web Services (AWS) account. Sign into AWS at https://aws.amazon.com/.
- You're familiar with the AWS EC2 user guides at https://docs.aws.amazon.com/ec2/index.html.
- Your organization has provided you the resources to access their AWS environment.
- On your host, you've installed the QNX Software Development Platform (SDP), which includes the QNX Momentics tool suite. QNX Momentics is a complete QNX Neutrino development environment.
- You're familiar with the QNX Momentics IDE User's Guide.

We use notes, cautions, and warnings to highlight important messages:

CAUTION: Cautions tell you about commands or procedures that may have unwanted or undesirable side effects.



DANGER: Warnings tell you about commands or procedures that could be dangerous to your files, your hardware, or even yourself.



ALERT: Alerts tell you about commands or procedures that could expose private information or otherwise compromise security.

Note to Windows users

In our documentation, we typically use a forward slash (/) as a delimiter in pathnames, including those pointing to Windows files. We also generally follow POSIX/UNIX filesystem conventions.

Connecting to an Existing QNX AMI Instance

This section describes how to connect to an existing QNX AMI instance from your host computer and the QNX Momentics IDE.

Checking the prerequisites for instance connections and access

Connecting to an existing instance requires that you have the proper access, which is provided by your organization.

- 1. Open the Amazon EC2 console at https://console.aws.amazon.com/ec2/ and choose Instances.
- 2. Locate and open the target QNX AMI instance. On the target instance page, make sure the instance is running. Otherwise, start the instance by choosing Instance state > Start instance.
- 3. Check the Security tab to ensure the security group allows your host computer to connect.
- **4.** Obtain the instance public DNS address and the key pair of the instance. If you didn't create the instance or the key pair, someone should provide you the key pair and your *userid* to access the instance. Record the file location where you saved the key pair.

Connecting to a QNX AMI instance with your host computer

To connect to a QNX AMI instance with your host computer, follow the instructions for using an SSH connection at https://docs.aws.amazon.com/AWSEC2/latest/UserGuide/AccessingInstances.html.

Another connection method is the EC2 serial console. Only one serial console can be active at one time for an instance and is usually reserved for the creator. Others connecting to the instance will use ssh.

Accessing the QNX AMI instance with the QNX Momentics IDE

To access your target instance from the QNX Momentics IDE and run programs on it, you must create a *target connection* on Momentics.

- 1. Open a QNX Momentics project on your host computer.
- 2. In the Target Navigator panel, create New QNX Target.
- 3. For Hostname or IP, enter the public IP DNS address of the QNX AMI instance.
- **4.** For **Port**, enter the port allowed in the instance security group.

Now you can use your instance with Momentics.

Launching a New QNX Amazon Machine Image Instance

This section describes how to use the Amazon EC2 Console to create and launch a QNX AMI instance.

Launching a new QNX AMI instance

Launching a QNX AMI instance follows similar tasks in "Step 1: Launch an instance" in https://docs.aws.amazon.com/AWSEC2/latest/UserGuide/EC2_GetStarted.html with a QNX-specific change:

 Under Application and OS Images (Amazon Machine Image), search for QNX and choose the most recent version as the AMI. This is the operating system (OS) image for your instance.

Some configurations to check:

- Under **Network settings**, choose **Edit**. Check that you have the appropriate VPC and security group. If you want public IP access, for **Auto-assign public IP**, select **Enable**.
- Under Storage(volumes), choose Advanced to reveal the EBS Volumes details. Open the volume
 details and check that Delete on termination is set to Yes.



For useful details on each item, choose Info.

When ready, launch your QNX AMI instance.

Booting a new QNX AMI instance

Once the new QNX AMI instance is ready, connect to it using the EC2 serial console.



For QNX AMI instances that are booting for the first time, follow the prompts to input new passwords for the root user and the qnxuser user. The first prompt will appear when you give keyboard focus to the EC2 serial console window and press ENTER.

Only one serial console can be active at one time for an instance and is usually reserved for the creator. Others connecting to the instance will use ssh. To allow connections from QNX Momentics IDE, run the qconn process.

You can use the QNX AMI image instance like any QNX-based system using the QNX product documentation at https://www.qnx.com/developers/docs/index.html.

Customizing the QNX Amazon Machine Image

The QNX AMI is a reference image generated by the QNX Image Filesystem (IFS) for developers to leverage the QNX Neutrino RTOS or the QNX OS for Safety as Amazon EC2 instances. The reference image does not contain all the libraries or binaries found on a non-AMI QNX system, and can't support the full range of functions and features found on a standard QNX target. You can't customize or tailor the QNX IFS that generates the QNX AMI reference, but the QNX AMI environment provides several customization options, including:

- managing user accounts, passwords, and groups
- adding files
- · adding storage and partitioning
- extending the boot

To save your customized QNX AMI, follow the Amazon EC2 User Guide at https://docs.aws.amazon.com/AWSEC2/latest/UserGuide/creating-an-ami-ebs.html.

Managing user accounts, passwords, and groups

When the QNX AMI instance first boots, it prompts you to input new passwords for the root account and the gnxuser account. Once complete, you can login as either root or gnxuser.

Like any QNX-based system, you can also add users or groups you want to the system. For detailed steps, see "Managing User Accounts" in the *QNX Neutrino User's Guide* at https://www.qnx.com/developers/docs/7.1/#com.qnx.doc.neutrino.user_guide/topic/about.html.

Adding files

Like any QNX system, you can use the Momentics IDE or the scp utility to copy or upload files from the host to the AMI instance, or vice versa. See the scp entry in the *Utilities Reference* at https://www.gnx.com/developers/docs/7.1/#com.gnx.doc.neutrino.utilities/topic/about.html.

Currently, the QNX AMI instance has two writeable partitions. To display partition information, run mount in the QNX instance terminal. For example:

```
# mount
/dev/nvme0t178 on / type qnx6
ifs on / type ifs
/dev/nvme0t179 on /data type qnx6
```

The first partition /dev/nvme0t178 is a 256MB "system" partition union mounted at / (slash), where you can upload (via Momentics or scp) your own libraries, binaries, and so on.



CAUTION: Do not change the permissions of the directories under this partition. If they are changed, users will no longer be able to log in.

You can add your own update management software as appropriate. As this partition is small, it should be reserved for "system" libraries and binaries and not the application-level libraries and binaries.

The second partition /dev/nvme0t179 is a 2.8GB writable partition mounted at /data. Run ls to list the directory content of / (e.g., ls /):



This partition should serve as the general integration point for any or all customizations to the application-level support files such as binaries, libraries, data files, config files, and so on. Again, you can use Momentics or scp to upload files to this partition.

The environment variables *PATH* and *LD_LIBRARY_PATH* are set to include certain directories in the **/data** mountpoint in addition to the standard system paths, ensuring that any customizations done within the **/data** mountpoint will get picked up during the boot sequence. To view what directories are set, run echo with \$PATH or \$LD LIBRARY PATH in the QNX instance terminal.

For example:

```
#
# echo $PATH
/proc/boot:/sbin:/bin:/usr/bin:/usr/sbin:/usr/libexec:/data/bin:/data/sbin:/data/usr/bin:/data/usr/sbin
# echo $LD_LIBRARY_PATH
/proc/boot:/lib:/usr/lib:/lib/dll:/lib/dll/pci:/data/lib:/data/lib/dll:/data/usr/lib
#
```

Adding more storage

Initially, there is one NVME device (nvme0) associated with the AMI. In the QNX instance terminal, run ls /dev to view the devices:

To attach an additional volume to an instance, follow the steps in "Attach an Amazon EBS volume to an instance" at https://docs.aws.amazon.com/AWSEC2/latest/UserGuide/ebs-attaching-volume.html.

When the volume is attached to the QNX instance, in the QNX instance terminal, run shutdown to reboot the instance.

After the instance reboots, the additional associated volume appears as the next NVME device nvmeN, where N is the next available number (e.g., nvme1).

Partitioning and formatting your storage

To partition a volume (e.g., nvme1), follow these steps:

1. Run

```
fdisk /dev/nvme1 add -t178
```

which creates a type 178 partition in nvme1.

- 2. Reboot the instance with shutdown, then run ls /dev to confirm that the nvme1t178 partition is added.
- 3. To format nvme1t178, run

```
mkqnx6fs /dev/nvme1t178
```

4. To mount nvme1t178 to a path, run

```
mount /dev/nvme1t178 / pathname
```

where pathname is any name you want. The mounted path is now available for use.

The QNX AMI instance can mount as many disk volumes as required.

Extending the boot

As mentioned previously, the IFS is not customizable. However, the QNX AMI environment provides two methods to extend the boot process:

startup script

The startup process looks for the existence of the script /var/start_script.sh. The IFS executes the script, integrating its code into the boot process.

• System Launch and Monitor (SLM) configuration file

The startup process also looks for the existence of an SLM configuration file /etc/slm/slm.conf. The SLM uses this configuration file to start and manage any custom components to run during boot. See the slm entry in the *Utilities Reference* at

https://www.qnx.com/developers/docs/7.1/#com.qnx.doc.neutrino.utilities/topic/about.html.

All extension options can be as complex or simple as you would like. If the user has their own software lifecycle management tool (to manage their application-level software), either the **start_script.sh** or SLM can be called to simply launch those custom processes such as starting the customer-specific process for the lifecycle management.

Managing Your Amazon Resources

It is important to manage your resources if you are no longer using them as you may incur charges from AWS. Amazon has useful documentation about key pairs, VPCs, security groups, volumes, and so on.
